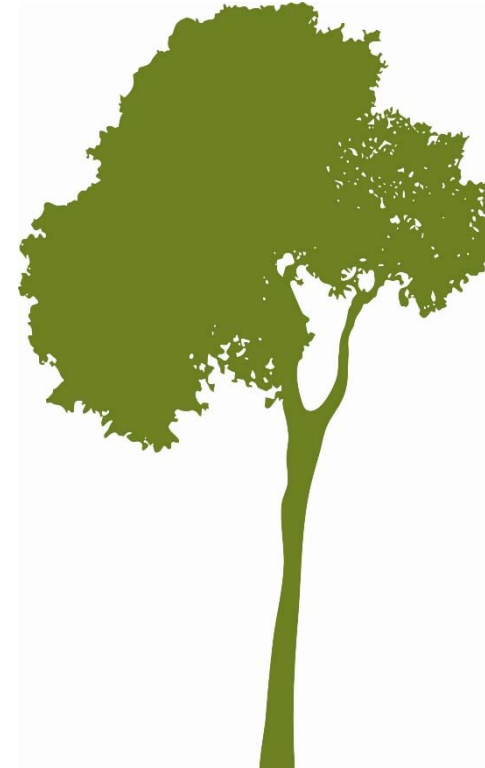

# The clinic concept

Learning from the collective knowledge

You share with the group a specific challenge you are facing in the development and implementation of your project

The group will share with you their experiences. By accessing the wisdom and experience of group, you will be able to:

- Generate new ways of looking at a challenge or question
- Develop new approaches for responding to these



# The roles are the following:

- **Case giver:** Share your question or problem statement that is current, concrete, and important. The presentation should be no longer than 10-15 min and the case should stand to benefit from the feedback of the peers
- **Peers:** Listen carefully to the case giver, share your experiences, your thoughts, and ideas (without trying to “fix” the problem)
- **Facilitators:** Just to facilitate the process



# Step-by-step instructions

- 1) The case giver delivers the presentation (10-15 min)
- 2) Participants listen carefully
- 3) Participants may ask for clarifications (only) (10 min)
- 4) Participants discuss and provide ideas as consist as possible (case giver only listens) (15 min)
- 5) The case giver selects ideas to further work on
- 6) All participants further discuss selected ideas
